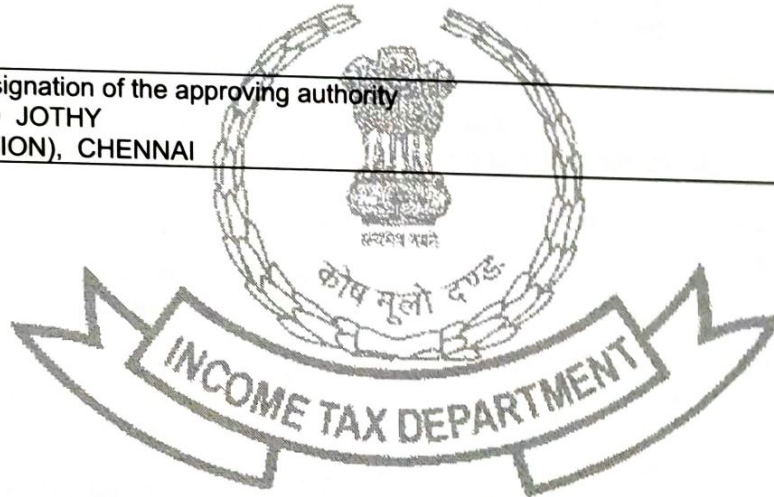

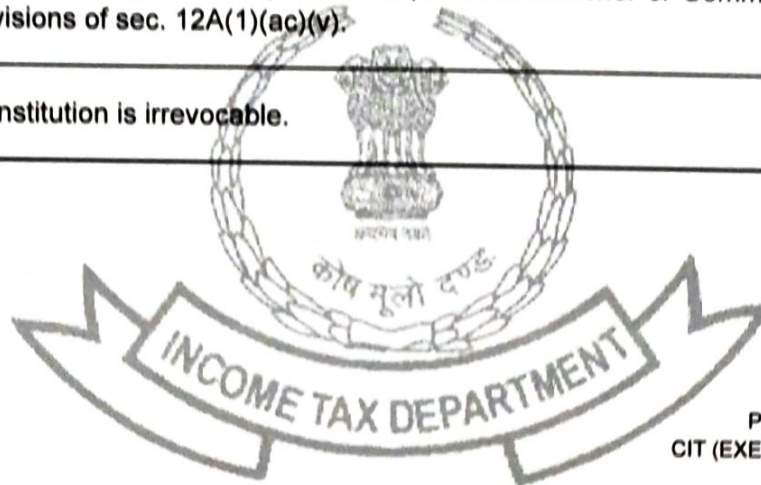

1	Please read Sl. No. (6) above "Section/Sub-section/clause/sub-clause/proviso in which approval is being granted" as under clause (ii)(b) of second proviso to section 80G(5) r.w.s 80G(5)(ii) of the Income Tax Act, 1961. This approval is granted subject to the continued validity of the 12AB registration.
2	The approval u/s. 80G is valid subject to the condition that trust/institution has a valid registration granted under section 12AB of the Income-tax Act, 1961 or approval granted under clause (23C) of section 10 of the Income-tax Act, 1961 and registration/approval has not been cancelled by the Principal Commissioner or Commissioner for specified violations as mentioned in sub-section (4) of section 12AB of the Income-tax Act, 1961 or under fifteenth proviso to clause (23C) of section 10 of the Income-tax Act, 1961.

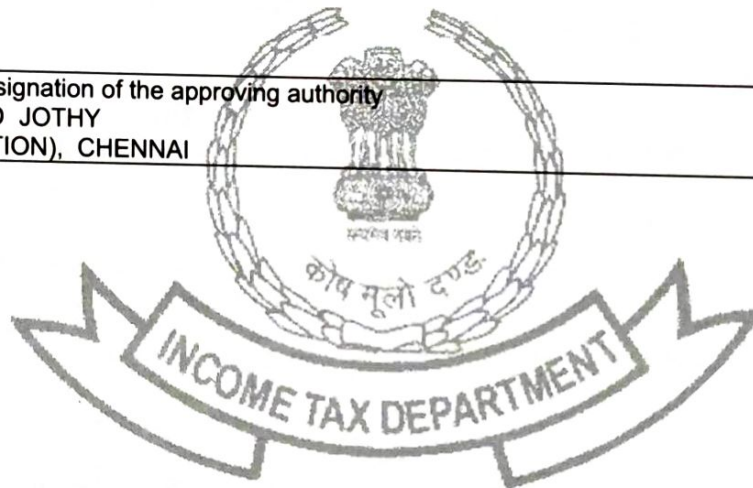

1	<p>The Trust/Society/Institution is registered as a Charitable Trust / Society / Institution.</p> <p>Please read sl. No. (6) above "Section/Sub-section/clause/sub-clause/proviso in which registration is being granted" as u/s.12AB(1)(b) r.w.s 12A(1)(ac)(ii) of the Income Tax Act, 1961.</p>
2	<p>Any income derived from property held under Trust, wholly or in part for charitable or religious purposes, shall not be applied, other than for the objects of the trust or institution.</p>
3	<p>The trust or institution shall not have income from profits and gains of business which is not incidental to the attainment of its objectives.</p>
4	<p>Separate books of accounts shall be maintained by such trust or institution in respect of the business which is incidental to the attainment of its objectives, in compliance to Section 11(4A) of the Income Tax Act, 1961.</p>
